Guidelines on Submission of Bank Guarantee & Affidavit for VLTD Manufacturers, Franchisees & Approval by RTO

The guidelines mentioned in this document shall be followed by the VLTD Manufacturers and their Franchisees for the submission of Bank Guarantee. The approval of the submission will be done by the respective RTO as per the guidelines mentioned in this document.

VLTD Manufacturers

- VLTD Manufacturers are required to submit the original of Bank Guarantee with 3 year validity and affidavit to C-DAC, Trivandrum for verification.
- Upon successful verification, the option for Franchisee Management (Add Franchisee Menu) will be activated in the application for the VLTD Manufacturer.
- VLTD Manufacturer using this option should add/update minimum 4 franchisees (1 franchisee for each zone) including the bank guarantee, GST and other details as shown below(Image of BG should be uploaded).

VLTD Franchisees

- VLTD Franchisee should submit the originals of the following documents to the Approval RTO for getting the franchisee approved.
 - Application Form
 - $\circ~$ Bank Guarantee with 3 year validity
 - \circ Affidavit
 - o GST Certificate

<u>RTO</u>

- RTO should receive and file all the original documents including the Bank Guarantee and Affidavit from VLTD Franchisees.
- RTO should Search for the application by entering the Application No in the Search bar.
- Select the application from the list and Click on Verify Button
- RTO should then verify all the details in the application submitted against the original documents including the Bank Guarantee, GST and Affidavit details.
- RTO shall approve the application if all the requirements are met. The following Checks should be enabled before approval as shown below and Approve button shall be clicked for approval.
 - o Verified Bank Guarantee Details submitted by franchisee
 - o Office Visited/Meets all the minimum requirements for franchisee
